## Lake District Update – Geography Lesson

I have written before about our attempts to address erosion issues in Lost Lake upstream from the rookery. We have made some progress on that project which I would like to share, but first I should take a moment to explain where this area is and why it is important. When we deal with the same issues every day, we sometimes forget that not everyone is familiar with what we are talking about.

### Rookery, Skid Row and Eagle's Nest

In the northeast corner of Lake Eau Claire is a large, shallow, weedy area known as the rookery. This area has been described as critical fish habitat by the WI Department of Natural Resources (DNR). It is also a very productive area for nesting waterfowl and other birds, as well as many species of mammals, reptiles, and amphibians. At the far eastern end of the rookery there is a small channel that forms a shortcut from the rookery to the main river channel. This shortcut connects with the main river just upstream of where the river enters the lake at the Skid Row boat landing, which is located at the east end of County Road SD. The area near where the shortcut and river channel meet is sometimes referred to as the Eagle's Nest as there is a prominent nest nearby.

### Lost Lake and Lost Lake Bank Stabilization Project

Halfway between the rookery and the river, the shortcut channel widens out and deepens in an area known as Lost Lake. Lost Lake is sometimes accessible by boat but is often cut off by fallen trees and sand bars. There is a large sand bank in Lost Lake that is eroding due to increased water flow through this area. The sand from this erosion is one source of sediment washing out into the rookery and forming a large sand bar. This sand bar growth is accelerating due to the increased frequency of high-water events and threatens the productivity of this important area. The district applied for a grant from the WI DNR to address the eroding bank and was partially successful in winning the grant. We were awarded a grant, but not for the full amount requested. Fortunately, we put the Lost Lake Stabilization project out for bids and accepted an offer below projections. Combined with a very generous donation from the Friends of Lake Eau Claire, we can cover the costs. The contractor is planning to complete the project this fall.

It is important to point out that this eroding bank is not the only source of sand entering the rookery. Deposits in the Eagle's Nest area have diverted some of the river's current so that more sediment is flowing through Lost Lake. A future goal is to address this issue with a large dredging operation from above the Eagle's Nest down to Skid Row. This will be a very ambitious project but will hopefully address many issues. Grants are being pursued, but we will need matching funds. One way you can help is to attend the Annual County Budget hearing on August 4<sup>th</sup> at 6:30pm at Augusta City Hall. This is our one chance every year to let the county finance committee know what an important resource Lake Eau Claire is for the entire county, and to ask for financial support for our ongoing projects.

## Boating Etiquette – the unspoken rules of the water

Recreational boating has an etiquette – the customary code of accepted behavior on and around the water. Boating etiquette is about safe behavior, as well as what's socially accepted. Here are some of the basics to help you navigate the boating world with ease while not creating a stir among fellow users of the water.

### Top 10 rules to respectful boating – make the right kind of waves

Remember, these are guidelines and should not serve as a replacement for learning the rules, regulations and laws for your local body of water.

1. **Respect the ramp.** Good boating etiquette starts before you enter the water - at the dock. Prepare your boat and equipment before getting into position to launch. Anything else is disrespectful to fellow boaters.
2. **Own your wake.** The fastest way to make the wrong kinds of waves is to literally throw a big, obtrusive wave at another boat, swimmer, angler or shoreline owner. This is much more than being a nuisance or disrupting others' experience on the water. It's dangerous to those unable to tolerate a large wake. Stay at least 200 feet from the shoreline and other boaters.
3. **Keep the tunes in check.** Sound is amplified over the water, so keep the music at a decent level. Not only is it a disturbance to others but the operator may not hear the spotter.
4. **Pack in. Pack out.** Seems like common sense, right? Yet shorelines are still lined with trash being thrown overboard. Take care of the body of water you love and dispose of any trash you have. Do not throw it overboard!
5. **Slow your roll.** Does the body of water you're on have a speed limit or slow-no-wake restriction? It's your responsibility to know it and respect it. You are responsible for any damage you cause to other people's property.
6. **Rules of the road.** Become familiar with waterway markers and navigation rules, which dictate how you operate your vessel in order to prevent collision.
7. **Be prepared.** If you are the captain, you need to be prepared with the safety rules for your craft and make your guests aware as well. Know state and local laws for the body of water you're on. Set a good example by always wearing a life jacket and have enough life jackets for each person onboard. Beyond that, make sure to have the appropriate fit.
8. **Fuel and go.** At the fuel dock, get fuel, pay your bill and move out of the way. If you need to buy additional supplies, relocate your boat. Don't forget to run your blower before starting.
9. **Anchoring and mooring.** Enter an anchorage or mooring area at a slow speed. Don't create a wake that will disrupt other anchored boats. The first boat sets the tone. Mimic how they tie off, how much line you use and how much distance you allow between you and other boats. The busier the boat, the more space you should give yourself.
10. **Be polite – give a wave.** When passing another boat, give a little wave hello. Boating is all about having fun and being part of the boating community. Embrace it, enjoy it, and share it for generations to come.



# What Is Riprap? And Why It Rocks!

You may have noticed a number of homes along Lake Eau Claire that installed riprap along their shorelines last winter. You may be wondering why do they need it and what benefit does it have for the lake. Below is some helpful information. If you are considering installing riprap, consult with the DNR to determine if you will need a permit before embarking on the project.

## What is Riprap?

Riprap describes a range of rocky material placed along shorelines, bridge foundations, steep slopes, and other shoreline structures to protect from scour and erosion. Rocks used range from 4 inches to over 2 feet. The size of the rock needed on a project depends on the steepness of the slope and how fast water is moving. Riprap is a very durable, natural-looking treatment.



## Where is it used?

Riprap is used where a structure or shoreline is continuously exposed to rushing water:

- Along a lake shoreline to limit erosion associated with wave action.
- Along the outer bank of a river bend, dissipating the force of the water against the bank.
- Near bridges along embankments and adjacent to supports in waterways.

Erosion can compromise shorelines which could cause loss of property; preventing erosion helps to keep the public safe.

**A REAL STUNNA!**

Maybe this article would be better titled "A REEL STUNNA!" because we are talking about a brand-new fishing bait that should produce here on Lake Eau Claire?

Berkley has just started manufacturing a long, thin minnow jerkbait called "The Stunna." The lure looks like a Rapala floating minnow but is actually much heavier and will dive, sit still for a second and then slowly sink down to a fish waiting for a meal. And its weight makes for a nice long cast.



The bait comes in two sizes: (1) is the Stunna 112. It is 112 mm long, weighs a hefty 1/2 oz. and dives from three to six feet based on the force used to snap the bait from side to side. (2) The Stunna 112+ 1 remains 112 mm long, weighs the same 1/2 oz. but has a deeper bill that causes the bait to run from six to ten feet deep.



I have used this bait myself with some of my customers when we have been fishing smallmouth bass on the Chippewa River. Colors that worked for me were in gold, orange, and grey shad. I recommend using 12 lb. test fluorocarbon line as it is pretty abrasive resistant, strong enough to bring in most northern pike, and invisible in the water. I also like to fish a snap (not a swivel snap) to connect the bait to the line. The lure can be use with a spinning rod and reel or a casting rod and reel, but if you choose to fish with a spinning outfit be careful about line twist. A spinning reel will put a half-twist of torque on every full revolution of the reel. One way to avoid that is to use a barrel swivel about 18 inches ahead of the lure, but you must be careful not to reel up the bait to cast it so that you bring the swivel into contact with your rod tip line guide.


Most fisherman work a jerkbait in the Kevin Van Dam fashion. They use short, strong rips to move the bait but allow for slack line to accumulate in between the ripping movements. A company that currently sells this bait on line is Susquehanna Fishing Tackle which can be found on the web at: <https://sfttackle.com>. Best of luck if you try it out. Let me know if it works for you.

# Roy Stevens' Musky Wins \$50

 Archie Buell has gathered some interesting facts on the musky fishing in Lake Eau Claire and the Eau Claire river during the three years that his musky contest has been in operation. The following article reviews the entries and the winners in the contest during the past three years.

It won't be long before another Musky season rolls around. Here are some of the high lights of last season's catch.

Roy Stevens won first prize of \$50.00 donated by Best and Riek Real Estate Co. of Woodville, Wis. and Glen Hardy salesman in this area. This fish was 46½ inches long and weighed 32 lbs.

Mrs. James Wallace won the second prize of \$10.00 donated by the River Inn. This Musky was 48½ inches long and weighed 28½ lbs.

In addition, Mrs. Wallace's Musky won second place at the Chippewa Fair and first place at Longs Sport Shop. Also first place at Osseo.

If Roy had entered his Musky at the Chippewa Fair, Lake Eau Claire could have won first and third prize for 1949.

Last year, 1948, the first and second prizes at the Fair came out of Lake Eau Claire. Dean Balliett won first place and Sev Plombon of Stanley won second place. Eau Claire would have had all three prizes in 1948 if Dean hadn't eaten a 25 pounder about two weeks before he caught the big one.

We have been running this contest since 1947 and have a record of all the Muskies entered during the past three seasons. Here is some interesting data.

The Musky catch as entered here since 1947 as to average length and average weight is as follows:

Year	Ave. Lth.	Ave. Wt.
1947	36.85 in.	13.20 lbs.
1948	37.80 in.	12.80 lbs.
1949	36.30 in.	11.55 lbs.

In 1947 some scales from twelve or fourteen of the Muskies caught in that season were sent to the fish division of the Conservation Dept. to determine the age of the fish. A report from Mr. Jacob H. Fischthal, who was connected with the fish division at that time, was returned.

Here is the dope on two of the fish, one river Musky and one lake Musky, these fish were the same length but the weight and age were somewhat different.

 Another Musky season is coming up soon, so if you catch a legal Musky enter it at the River Inn. It may be good for one of the monthly prizes and will give a lot of information to fishermen.
