

Friends of Lake Eau Claire Board Meeting Agenda July 13, 2019 at 9:00 am at Black Bear

- Meeting called to order by President Lori Bechtel at 9:00am. Present: Lori Bechtel, Dean Boehne, Al Hendricks, Fred Poss, Dan Marcheske, Dale Zank, Pam Hanson, Duane Ives and Marc Christopher Absent: Phil Kalscheur, Cathy Lea and Amy Quella. Guest: Marlo Orth
- 2. Review of previous minutes dated May 18, 2019 and were approved.
- 3. Treasurer's report Financial statement presented by Dean. Sponsorship and donations are up from last year. Motion to approve as presented by Fred, second by Duane. Vote was unanimously approved.

- 6. Fred Poss gave an update on Northside creek dredging. He is working on getting a quote from a new trucking company to complete the dredging and cost may rise to \$3k from \$2k. Anticipate completing in July.
- LECA boat & motor Fred and Dale have been looking for a pontoon motor. Fred spoke with someone that may donate one. If not, we may have to solicit donations.
- Fish crib installation date September 14<sup>th</sup> we will be looking for volunteers. Need branches about 8' long by end of August/early September.
- 9. Lori gave an update on 2019 Fundraiser updates/planning
  - a. Calendar fundraiser was very successful and exceeds funds raised over the 2018 triathlon. Al recommended at the end of the drawings to post a bulletin of ALL winners and thanking all who participated.
