All progress billing invoices with be reviewed by the Board to verify that terms of the contract are executed correctly. The Board requested progress billing to better manage cash flow while using District and County funds.
- The Eau Claire County funds of \$65,000 will be received following District submitting paid invoices to the County for work completed by Shane Krueger.
